Interested firms should submit their documents satisfying the technical bid requirements in a sealed cover, superscribed with 'Technical bid' (as per Annexure-1) along with another sealed cover superscribed as 'Financial bid' (as per Annexure-2). Both the envelopes should be sealed and placed in another sealed envelope superscribed "Tender for hiring of Photocopying machine" and send to the Administrative Officer, Room No.478, 4<sup>th</sup> Floor Hotel Samrat, Chanakyapuri, New Delhi-110021 latest by the date and time mentioned above. The bids will be opened on the same date & time as mentioned above in Room No. 478, 4<sup>th</sup> Floor Hotel Samrat, Chanakyapuri, New Delhi. Bidders and their representatives are welcome to remain present during the opening of the bids.
- 2. Technical bid should be accompanied by an earnest money deposit (EMD) of Rs.10000/- in the form of Demand Draft or Pay Order in the name of the 'DDO, TDSAT' payable at New Delhi. Technical bid received without EMD shall be summarily rejected without assigning any reason there of and no tenderer shall have any right to represent against it, even if, his quotation happen to be lowest. Earnest money received from the tenderers will be

returned without interest immediately after the process of selection of tender/ quotation is over.

#### **General Conditions**.

- 3. The firm is required to provide one new heavy duty photocopier machines of latest models with duplex facilities having a speed of minimum 45 copies per minute (back to back). The requirement of number of machines deployed of the said model may be increased as per the requirement of the office and hiring of the same will be governed on the same terms & conditions of the tender document.
- 4. The minimum guarantee of number of pages to be photocopied will be 120000 per annum or prorata basis, if the period of contract is less than a year.
- 5. The successful bidder shall be required to furnish Performance Security of Rs.20000/- in the form of FDR or Bank Guaranty duly hypothecated in favour of "DDO, TDSAT" within a week after award of the contract and valid beyond 60 days after the expiry of the contract.
- 6. The men power, space, Paper and electricity will be provided by TDSAT whereas maintenance of the equipment (to ensure that these are in perfect working condition) will be the responsibility of the firm.
- 7. All the consumable required like toner, drum, spare parts etc. will be provided by the firm.
- 8. The payment will be made on monthly basis subject to the satisfactory performance of the firm. Reading will be verified by the Administration Section, TDSAT on monthly basis.
- 9. The contract will be initially for a period of one year and may be extended further subject to the satisfactory performance of the firm.
- 10. The TDSAT has the right to terminate the contract in case of performance and the service rendered by the contractor/ firm is found to be unsatisfactory, by giving a notice of 7 days.
- 11. Only qualified and experienced engineers/ technicians/mechanics, whose character and antecedents have already been verified, will be deputed to attend the repair works of machine deployed by your firm in the office of the Tribunal.

- In the case of delay in attending to the complaints within a day penalty @ 12. Rs.200/- per day will be levied
- If the machine is not repairable within a day a separate Machine of the same 13. model should be provided immediately otherwise an amount of Rs.1000/- per day will be deducted.
- EMD of the unsuccessful tenderers will be released, without any interest, after 14. finalization of the contract. EMD of the successful bidder will be released, without any interest, only after the firm has submitted Performance Security with the TDSAT.
- The EMD shall stand foefeited if a bidder withdraws or amends the bid/ tender 15. or in case successful bidder fails to sign or accept the contract within the stipulated period. No interest will be payable on this amount. The EMD shall also stand forfeited in the event of premature withdrawal of the tender(s) by any of the tenderes.
- The TDSAT reserves the right to accept or reject any tender, in whole or in 16. part thereof, without assigning/ specifying any reason thereof.
